

Terms and Conditions

1. OVERVIEW. The Merz Aesthetics Xperience Program (the “**Program**”) is sponsored by Merz Pharma Canada Ltd. (“**Merz Aesthetics**” or the “**Sponsor**”). The Program starts on March 1, 2019 at 9:00AM (EST) and ends on September 30, 2019 at 11:59PM (EST) (the “**Program Period**”). The Program is comprised of a rebate payable in the form of a Merz Aesthetics Visa® Prepaid Card on qualifying minimum purchases of select Merz Aesthetics products and is subject to the terms and conditions herein. A \$50 Merz Aesthetics Visa Prepaid Card is provided for the purchase of Xeomin Cosmetic®, Belotero®, Radiesse® and a \$100 Merz Aesthetics Visa Prepaid Card is provided for the purchase of an Ultherapy® treatment. The Merz Aesthetics Visa Prepaid Card is issued by Peoples Trust Company pursuant to a licence from Visa Int. *Trademark of Visa International Service Association and used under licence by Peoples Trust Company.

2. ELIGIBILITY. This rebate offer is contingent on the purchase of Xeomin Cosmetic®, Belotero®, Radiesse® or an Ultherapy® treatment from a participating authorized clinic during the Program Period, subject to the following minimum pre-tax purchase requirements: Xeomin Cosmetic® \$300, Belotero® \$400, Radiesse® \$700, Ultherapy® \$1500 (a “**Qualifying Purchase**”), and is open to legal residents of Canada who are 18 years of age or older at the time of purchase. Multiple rebates during the Program Period are only permitted where Qualifying Purchases occur at least 120 days apart. Late submissions will not be accepted. To apply for the rebate, visit www.xperiencemerz.ca and follow the directions to enter in your name and address and upload your receipt. The name of the Merz Aesthetic product purchased or treatment received must be clearly identified, and the pre-tax purchase price must be equal to or greater than the minimum purchase requirement for that product. Sponsor reserves the right to request additional proof of a Qualifying Purchase at its sole discretion and to delay the processing of any rebate submission without notice to you in order to validate compliance with these Terms and Conditions. When a rebate submission is approved by Sponsor, a Merz Aesthetics Visa Prepaid Card will be delivered by first class mail to the address recorded in your rebate submission. **Allow 6 to 8 weeks** for the delivery of your Merz Aesthetics Visa Prepaid Card. Incomplete rebate submissions will delay processing and may be refused by Sponsor at its sole discretion. Keep copies of all documents for your records, as well as a record of the date your rebate request was submitted. All submitted documents will become the property of Sponsor and will not be returned.

BELOTERO Lips Shape is an injectable implant indicated to restore or significantly increase the volume of the skin tissue which enables increasing the volume of the lips (the border of the red part of the lips or increasing the roundness). Contra-indications: BELOTERO Lips Shape is contra-indicated: In case of known hypersensitivity to one of the product's components, especially to sodium hyaluronate, lidocaine hydrochloride and other amide-type local anesthetics, in pregnant or breastfeeding women, in young patients under 18 years old, in patients presenting general infection, in patients who have a predisposition to keloid scarring. Do not inject BELOTERO Lips Shape into blood vessels. Do not inject BELOTERO Lips Shape into area presenting cutaneous problems of inflammatory or infectious type (acne, herpes). Do not inject BELOTERO Shape into an area previously treated with permanent dermal filler. Do not inject BELOTERO Shae in glabellar region. of the gel. BELOTERO Lips Contour must be injected into a healthy, non-inflamed and previously rigorously disinfected skin. It is recommended to use one of the supplied needles. To ensure optimal use of BELOTERO Lips Contour, it is recommended to assemble the needle according to the diagrams provided in Instructions for use. The practitioner should note that the use of 30G ½ needles requires greater force to inject the gel than 27G ½ needle. BELOTERO Lips Contour can be used in combination with other BELOTERO products during the same session. Instructions for use of each product should be followed.
